## Terms and Conditions

1. Squad fees are based on a 39 week training year for academy sessions.
2. The first month's payment is taken in deposit form upon successful application and then regular payments are 1st of every month thereafter up until and including August 2023. The Funded Player Agreement stands until 31st August 2023.
3. The Funded Programme is a one year commitment. Players wishing to leave the programme before the end of this agreement must give a minimum of 3 months notice in writing. This can be via email to Matt – [matt.smith@virtuslm.co.uk](mailto:matt.smith@virtuslm.co.uk). A player can be removed from their programme immediately at the discretion of the Virtus Management team. In this instance, payments will be halted from the following month.
4. Should payment not be made in accordance with the payment plan selected, the player's programme will be stopped immediately.
5. In the event of a failed auto-payment we will attempt to re-run the payment the following day at no extra charge. In the event of a 3rd failed auto-payment, a £50 processing fee will be added to the cost of that month's payment.
6. In the event of having to take recovery action for payment, an administration charge of £80 + VAT will be applied plus the costs incurred for the recovery.
7. Any pauses in payments due to injury or illness for example will be discussed on a case by case basis by Virtus Management.
8. Any funding received by the LTA will be in strict adherence with LTA rules.
9. Upon successful application a deposit of the first month's fees must be paid within 1 day.
10. Funded programme players are expected to be available for Team Events. Player selection will be discussed with the Performance Team and players will be expected to show Bromley as their first choice.
11. Media policy:- Virtus/BTC is involved in local and national media. By signing this contract you are agreeing to your child's image and likeness being used in any photos or videos. Please confirm with us in writing if you do not give permission for your child's image to be used in any promotional material.
12. Players and parents are expected to behave in a professional manner and support BTC/Virtus at the Centre and at other venues and value the reputation of BTC and any associated coaches.
